## The Department of Analytical Chemistry at the Connecticut Agricultural Experiment Station (CAES) is seeking applications for a Seasonal Employee.

Per- and polyfluoroalkyl substances (PFAS) also known as "forever chemicals" are an emerging class of contaminants which are of global concern. These man-made chemicals have minimal biodegradability and are harmful to the environment and human health. Current technologies for the removal of PFAS from soil and water are limited and challenging. We are investigating a cost-effective remediation method for PFAS using nanomaterials that enhance plant accumulation of PFAS from soil. The selected candidate will be responsible for sample preparation and processing of soil and plant samples and will assist other project staff with sample analysis and the development of a hydroponic system for growing plants at CAES.

We are seeking a current undergraduate student or recent graduate with experience in analytical chemistry, chemistry, environmental sciences, or a related field. Job requirements include:

- Strong interest in working on emerging contaminants in the environment
- Willingness and ability to learn sample preparation and analysis of PFAS
- Excellent communication skills
- Ability to work independently and as part of a team

## Preferred qualifications include:

- Completion of general and organic chemistry courses with lab
- Interest/experience growing plants
- Previous laboratory experience
- Valid U.S. driver's license

The candidate should demonstrate enthusiasm for the project and a willingness to learn new skills. The ideal position start date is February 6<sup>th</sup> and position will last for 6 months. Hours will be variable and determined based on project needs and employee availability (approximately 10 hr per week during the school year and up 35 hours per week over the summer). Hours will be between 8:30 am and 4:30 pm Monday through Friday. The salary will be \$13/hour.
