Item 1 CLARIFICATION – PROJECT MANUAL FOR BIDDERS:

Refer to the 'Objective Criteria for Evaluating Qualifications of Bidders' for the bidders/contractor qualifications for bidding and for actually doing the work described in the documents. The University has very strict requirements that a contractor must have the experience and capability to do the work.

The Owner will consider requests for equals or substitutions if made prior to the Receipt of the Competitive Bid. The information on all materials shall be consistent with the information in the specifications.

- <u>Required Forms and Information</u>
 First sheet, 'Forms to be Returned' lists all forms required including DAS Prequalification Certificate.
 During construction, except for items that need notarized signatures or original signatures, all submissions & communications must be via email with any attachments in pdf form.
- 4. <u>Contract Award</u> One Single Lump sum bid for project. Purchase Order will be issued after contract is signed.
- <u>Review of Bid Proposal Form</u> Liquidated Damages: \$300.00/day Insurance Requirements GC must do at least <u>30%</u> of the work with its own forces

The General Contractor on this project shall be required to award not less than 50 % of the Remaining Contract <u>Value</u> – that is the value left after subtracting the value of self-performed work by the GC – to subcontractors who are certified and eligible to participate under The State of Connecticut Set-Aside Program for small contractors – this includes SBE, MBE, and WBE contractors. Participating contractor list may be obtained by going to <u>www.das.state.ct.us/purchase/setaside</u>.

GC must make a good faith effort to employ subcontractors who are certified and eligible to participate under The State of Connecticut Set-Aside Program for small contractors.

6. Project Schedule

Purchase Order will be issued soon after the lowest qualified bid is accepted, and contract signed. <u>Work shall begin at the 1st building on May 16, 2022</u>, and Substantial Completion for the work at all of the buildings for the <u>Residential Halls – Security Screens - 2022</u> shall be no later than <u>July 30, 2022</u>.

- Prevailing Wage Rates Applicable for this Project Certified Payroll – must be submitted with payment application.
- Insurance Certificates, Bonds, Affirmative Action Plan Insurance Certificate required with proposal Performance and Material and Labor Bond required after contract award Affirmative Action plan needs to be submitted to CHRO within 10 working days of bid op'g and before starting work on the project.
 - 2% will be withheld from payments until plan is approved.
- 9. <u>Use of the Premises</u>

Field office will not be required for this project, but contractor must provide a cell phone to the Project Superintendent for immediate 24 HOUR phone access by SCSU. Project Superintendent must be on site whenever any workman is on site. Storage Trailer Location is shown on Location Map. Lead - None expected - Working with aluminum windows. All buildings built or renovated after 1978. Asbestos – Not expected, advise University of any concerns. Bid No.: RFQ-22-SCSU-01
