Re-Bid North Campus Townhouse Units Renovations - 2020

In accordance with Section 4a-57 of General Statutes of the State of Connecticut, sealed proposals for supplying the following will be received by the Procurement Services Department, but in the interests of safety during this time, with University facilities closed, preventing a public bid opening due to the Covid-19 pandemic crisis, bids will be received electronically not later than 2:00 PM on Tuesday, June 23, 2020. Bid package shall be forwarded to the e-mail address procurement@southernct.edu. E-Mailed bids received after 2:00 PM will not be accepted, with the University being the sole arbiter on the acceptance of a bid. The University shall not be held responsible for errors in transmission or any situation which prevents a bid from being delivered electronically prior to 2:00 PM. For proper identification, bidders are asked to note the bid number and project name on the subject line of the e-mail. Bid results will be posted on the DAS portal as soon as practicable. See the Instructions to Bidders for more information.

The Project Description:

Project is for the Renovations of the North Campus Townhouses (16 Units) in two phases.

Removal/Replacement of existing tubs, toilets, and sink/vanities. (Tubs to be replaced with fiberglass shower units.) Removal of existing ceramic tile floor, Replacement with vinyl flooring. (Allowance for Removal/Replacement of subfloor & fill.)

Removal/Replacement of existing Kitchen cabinets & countertops. Removal/Replacement of appliances by contractor – appliance cost fixed in a separate appliance subcontract by supplier with GC. Removal of carpeting throughout – Replacement with LVT plank except for new carpet at stairs. Removal/Replacement of front door and frame.

Removal/Replacement of 2nd floor exterior decking and railings. All walls and ceilings to be painted.

Removal/Replacement of HW heater, furnace, condensing unit, and all piping. (New furnace to be gas fired combination boiler and fan coil unit.) Removal/Replacement of Bathroom exhaust fan and Kitchen hood – new Bathroom exhaust fan & Kitchen hood to be ducted to exterior.

Alternate Bid for cleaning of any remaining existing ductwork.

NOTE: The second floor Unit A-8 is to be finished first as a model mock-up unit with all finishes and equipment in place. Although demolition can continue at the other units, no finish and equipment work may be done anywhere until the completed work at Unit A-8 is reviewed and approved.

In accordance with C.G.S. 46A-68d, the successful qualified low bidder on this project shall submit an Affirmative Action Plan if the value of the project exceeds \$50,000.00 or more. The plan must be filed within thirty (30) days after a bid has been accepted by an awarding agency.

There will be **NO MANDATORY PRE-BID CONFERENCE and walk through of the site**. Photos of some of the existing conditions are part of the bid drawings. The bid package and accompanying drawings are available on both the DAS and SCSU's websites.
