- P & T Senate Procedures document (Discussion)
 - Discussion to clarify language regarding eligibility to serve on P & T Committee while on leave
 - Motion: Tricia Lin, Alison Wall 2nd, the committee shall move to add the following language to the P&T Procedures document: "Faculty members on any form of university leave (See CBA Article 13) shall not serve on the P&T Committee during their leave."
 - Discussion of the Comparable Qualifications language:
 - Consensus on the addition of the following language under "Supporting Materials for Comparable Qualifications":

"The determination of comparable qualifications belongs solely to the DEC. A faculty member's supporting documentation for such a determination shall be submitted separately from the Promotion and Tenure file."

- Role of HR in notifying departments, DEC's and faculty candidates during penultimate year:
 - It's currently HR's responsibility to notify individuals in their penultimate year that application for P&T is mandatory.
 - Consensus recommendation: Responsibility for notification will remain with the administration. Since notifications are periodically inconsistent, the Senate should this up with the administration to ensure notifications resume. The PPC recommend the discussion move to the Executive Committee.
