August 30, 2023

Faculty Senate President Natalie Starling called the 1st meeting of the Faculty Senate to order at 12:13 p.m. in Engleman B121 A/B and via Zoom.

- I. Announcements
 - A. T. Lin reminded the body of the Multicultural & International Welcome Reception, which will be held August 31 from 4-6 in the Adanti Student Center Ballroom.
 - B. L. Cunningham reminded the body of the upcoming Sabbatical Leave information session to be held September 1 at 1pm via Zoom.
 - C. The Inaugural Social Justice Conference hosted by the Division of Diversity, Equity & Inclusion will be held on September 22 from 12:30-6 p.m.
 - D. T. Tyree thanked everyone who participated in the beginning of the year events for students.
 - E. N. Starling asked if there were any objections to changing the order of business. Hearing none, the order of business was changed to welcome President D. Smith and Provost R. Prezant.
- II. Guests
 - A. President D. Smith: welcomed Senators and shared his enthusiasm for the Fall semester. He shared that the number one priority is enrollment, retention, and degree completion of our scholars. He shared that we are facing a large financial challenge. He stated that he would like to be as transparent as possible. He shared that this fall we will launch our five-year strategic plan.
 - B. Questions/comments included
 - i. A thank you to facilities: the campus looks great.
 - ii. Question regarding nontraditional students as a recruitment focus; also, does the university have plans to engage in more recruitment, to move more aggressively like some of our sister institutions?
 - iii. Question regarding communication: will the President's office continue the direct line of communication-style like under the previous president?
 - C. President Smith shared that we cannot wait until January to being engaging with the legislature; we should be doing so on a continual basis. He reminded the body of the upcoming Town Hall with more details to come.
 - D. Provost R. Prezant: welcomed new and returning Senators; he shared his enthusiasm for the Fall semester, but also shared that it will be a semester filled with challenges. He reminded the body of the upcoming meeting on September 1 at noon in Engleman C112 and Teams to discuss the Academic Planning Program as mandated by the Board of Regents (BOR). He shared that the plan is not definitive and is currently in draft form. He shared that first year student enrollment is flat, which is positive as previous first-year enrollment had been down. He shared that they are most concerned about part-time enrollment, which is down. He shared the transition plan in SPAR: J. Fowler is now in the role previously occupied by A. Taylor. He also shared that there are currently \$17 million in grants pending.
 - E. Questions/comments included
 - i. question regarding our institution's aspiration to become a Hispanic Serving Institution: is that still a goal? President Smith said yes, it is.
 - ii. Question regarding the timeline for the Academic Program Assessment, since it overlaps with faculty evaluation. Provost Prezant shared that it was a timeline set by the BOR.
 - iii. Question regarding the university-wide Promotion & Tenure (P&T) event vs. college/school-wide event. President Smith and Provost Prezant stated that they would review this decision.

- iv. Concern that the union (AAUP) is not involved in the Academic Program Assessment since it may eventually impact faculty employment. Provost Prezant stated that this is a curricular issue, and the union would not have standing. Following up on this comment, the speaker stated that the financial troubles are due to decisions made above us at the legislature and their lack of financial support. There is concern that the assessment will provide a mechanism to merge or eliminate programs.
- v. Comment regarding "free" tuition at Community Colleges and if the same program might be applied to the four universities?
- F. The body thanked President Smith and Provost Prezant for their time.

- B. C. Simoneau reminded Senators of the CSU-AAUP Travel funds, which stand at \$3,000 minimum for full-time faculty and \$1,000 minimum for part-time faculty.
