Faculty Senate President Natalie Starling called the 3rd meeting of the Faculty Senate to order at 12:11 p.m. via Zoom.

- I. Announcements
 - A. S. Benes: Faculty Development event on Inclusive Pedagogy on 10/13/23 12-3pm.
 - B. K. Kruczek: Self nominations for All University committee elections are due by Friday at noon.
 - C. C. Simoneau: Food pantry is distributing collection boxes across campus. Let them know if you would like to host one.

- IV. Reports of the Faculty Senate Standing Committees
 - A. N. Starling shared an overview of the current Standing Committee charges (see "Documents to Accompany Minutes..." below).
 - B. Academic Policy (M. Uribe): Committee is waiting for the Retraining committee to convene and elect a chairperson; our first meeting to discuss microcredentials is scheduled for next week; bookstore issues continue, but it was discovered that a number of common sections (ENG 112 as an example) do not have books listed for *all* sections, which may be some of the issue with not enough copies available; the System office has not announced who will be the new bookstore provider.
 - C. Elections (K. Kruczek): List of part-time faculty from HR is forthcoming, which is the reason for the delay in part-time faculty elections. L. Eilderts suggested changes to governing documents that would allow part-time faculty representatives to remain in their elected positions until election results have been declared.
 - D. Finance (C. Simoneau): Shared information on the healthy faculty travel budget. An inquiry about the interest accrued on accounts revealed that any interest accrued goes into the University's general fund, it is not returned to the individual accounts.
 - E. Rules (P. Petrie): The Working Group on governing documents is waiting for the election of two representatives from the UCF to begin its work.
- V. Reports of the Faculty Senate Special Committees
 - A. Reports received from UCF and Grad Council.
 - B. UCF (M. Barboza): UCF and Grad Council are no longer a part of the Academic Program Process but are available to provide assistance. The Star committee work continues. No one has stepped forward for the Working group yet. Please continue to submit proposals to the UCF as outlined on Confluence. Shared that there are potential changes to the LEP that would require a referendum. N. Starling shared a point of information: referenda of this nature are hosted by the Faculty Senate.
 - C. Graduate Council (B. Cook): Shared that a search committee has been formed for the Dean of the School of Graduate and Professional Studies. Shared that the GC hopes the Workgroup on governing document will be formed soon since there are pending

changes to the GC bylaws that cannot be finalized until the Workgroup concludes its business.
