November 1, 2023

Faculty Senate President Natalie Starling called the 6th meeting of the Faculty Senate to order at 12:12 p.m. via Zoom.

- I. Announcements
 - A. T. Lin shared information regarding Native American Heritage Month (<https://www.southernct.edu/native-american-heritage-month>).
 - B. L. Eilderts thanked Dean Kalk, Provost Prezant, President Smith, and the department of World Languages & Literatures for their support of the French-language hip-hop concert on October 30th. 1,300+ middle and high school students from across Connecticut attended.
- II. Minutes of the previous meeting held on October 18, 2023, were accepted as distributed.

- III. Faculty Senate President's Report

 - A. N. Starling thanked Provost Prezant for sharing a draft of the APP report with the Faculty Leadership Council (FLC).
 - B. M. Shea asked about the information regarding credit for prior learning and if this information had been shared with the UCF. M. Barboza shared that this issue has been sent to UWIC. Provost Prezant shared that, ultimately, the policy will be decided by the individual campuses. N. Starling shared that the timeline for feedback is by the end of the semester.
- IV. Reports of the Faculty Senate Standing Committees
 - A. Reports of the standing committees have been received.
 - B. Elections (K. Kruczek) shared that the recent elections have been completed and the results would be shared with the elected members shortly. N. Starling shared that there is still a seat on LTEC for the College of Education; Senators from that college are encouraged to share this information with colleagues.
 - C. Finance (C. Simoneau) shared that a University Budget committee meeting is scheduled for November 6.
 - D. Student Policy (E. Horch) shared that the committee is working on a resolution to address midterm grade reporting. Future topics include the availability of menstrual products on campus.
 - E. Technology (D. Macur) shared that IT has been working with our vendor Ellucian (Banner and Degree Works) to resolve an authentication issue. The committee is also working closely with IT to design a more transparent way to track learning technology issues/tickets; this information will be provided by IT, and the Technology committee will distill it into a faculty-friendly format. Faculty are and will be encouraged to share any future questions about the data and its tracking with the chair of the Technology committee.
- V. Special Committees
 - A. UCF (M. Barboza) shared that they have been asked to provide general equivalencies of our general education program with the other schools; TAP/FIRC is being dissolved by the end of the academic year.
 - B. Graduate Council (B. Cook) reminded senators to go to the GC Confluence website for the most up-to-date forms. Also reminded senators that the GC revised their bylaws, which prompted a

review of Faculty Senate and UCF bylaws; thankful that the working group has met and that this work is underway. Next steps include a review by the Faculty Senate's rules committee; M. Barboza clarified that the revised UCF bylaws have not yet been voted upon. N. Starling shared that, since all documents need to be consistent among themselves, all three bylaws will be put forward for approval by Faculty Senate at the same time (following UCF and GC approval of the respective by-laws of those bodies).

VI. Updates from the University President

- A. President Smith shared that we are exploring different deficit mitigation models to see which one would best suit the institution. Currently the model that appears the most compelling is leaning towards enrollment growth and a tuition increase. The deficit mitigation strategy does not include any involuntary layoffs of faculty or staff. M. Rozewski is meeting with the system CFOs, and there will be a meeting November 6 to share more information with the University Budget committee. President Smith shared that he appreciated how the entire university community is on board with enrollment growth, retention, and persistence.
- B. President Smith shared that he would like to have room for respectful public discourse concerning the events taking place in the Middle East. Universities have been at the forefront of social change, and he believes that we have a role to play. More information regarding future events and opportunities for dialogue will be shared with the university community.
