

SCSU Faculty Senate President's Report – September 1, 2021 meeting

- 1) **Welcome** – Senators, welcome to a new academic year and a new year of Faculty Senate business! I would like to express a very warm welcome to our new Senators. I will ask you to introduce yourselves at the beginning of the meeting.

- 2) **Announcement – Faculty Creativity Activity Research Grants (FCARG)** – Due to a realignment of the funding for the FCARG award in order to have the disbursement of the funds and the award period occur in the same fiscal year, we have an additional \$85,000 in the FCARG fund for this year. Given this fortuitous situation, there will be a special award period for these funds that will be disbursed this fiscal year (July 1, 2021-June 30, 2022). The announcement for this special award will be sent soon and will have an abbreviated timeframe for both the submission of the application and the committee deliberations. Stipends will be distributed immediately and any operational expenses will need to be utilized by June 30, 2022. Any faculty member who has already received an FCARG award for the current year (paid in spring 2021 for the July 2021-June 30, 2022 award period) will not be eligible for the special award. In other words, applicants cannot receive two FCARG awards in the same fiscal year. Faculty members who applied for the award last year who did not receive the award are eligible to apply for the special award.

This does not affect the regular FCARG award for which all faculty may apply. The application for the regular award will be available during the usual timeframe this semester for the July 1, 2022-June 30, 2023 fiscal year.

3) **Preparation for 9/1/21 meeting**

Although these topics may fall out of the traditional charges of a given committee, it has been our practice in recent years to do this in order to accommodate our workload and also to create a more equitable structure in which all standing committees have a similar workload. The committees that may be more likely to deal with the waiting list topics are Finance and Elections. Senators who are potentially interested in dealing with a broad range of topics may find this option desirable.
