FACULTY SENATE

Resolution Regarding Load Credit for Faculty Leadership in the Undergraduate Curriculum Forum (UCF)

Whereas, Southern Connecticut State University exists for the primary purpose of furthering academic excellence;

Whereas, The Faculty Senate is the official governing body for shared governance;

Whereas, The Faculty Senate recognizes that, to further academic excellence and to ensure shared governance is upheld, load credit is necessary for the labor of the faculty leadership in the Undergraduate Curriculum Forum (UCF);

Whereas, The UCF By-Laws specify some of the required labor associated with the duties of multiple UCF positions; and

Whereas, The Faculty Senate has a duty and responsibility to give consideration to load credit in quantities that reflect the labor of faculty leadership in the UCF; now, therefore, be it

Resolved, That effective beginning in the Fall semester of 2025, the load credit for the UCF shall be as follows:

- 8 credits for fall semester and 8 credits for spring semester assigned to the **Chairperson of UCF**.
- 1 credit for summer "A" or summer "B" semester assigned to the **Chairperson of UCF**.
- 6 credits for fall semester and 6 credits for spring semester assigned to **Chairperson of the Notifications Management Committee (NMC)**. In circumstances wherein there are two co-chairs of the NMC Committee, each co-chair shall be assigned 3 credits for fall semester and 3 credits for spring semester.
- 2 credits for fall semester and 2 credits for spring semester assigned to the **Chairperson of the University-Wide Impact Committee (UWIC)**.
- 2 credits for fall semester and 2 credits for spring semester assigned to the **Chairperson of the Liberal Educational Program Committee (LEPC)**.
- 2 credits for fall semester and 2 credits for spring semester assigned to the **Chairperson of the Writing Across the Curriculum Committee (WACC)**.
- 2 credits for fall semester and 2 credits for spring semester assigned to the **Chairperson of the Standards and Assessment Review (StAR) Committee**. In circumstances wherein there

are two co-chairs of the StAR Committee, each co-chair shall be assigned 1 credit for fall semester and 1 credit for spring semester.
